REGISTRATION OF RIDER AND AGREEMENT PURPOSE: In consideration of the payment of a fee and the signing of this agreement, I, the following listed individual, and the parent or legal guardians thereof if a minor, do hereby voluntarily request and agree to participate in riding instruction as a student at Alpine Ridge Farms LLC, and that this student will wither ride his/her own horse, or a school horses provided by Alpine Ridge Farms LLC for instructional purpose, today and on all future dates:

PAYMENTS: Package deals must be paid for in advance to taking any lessons. Each package must be completed. There are No refunds periods. No exceptions! Lessons are consecutively scheduled weekly lessons.

There will be a \$25.00 late fee for lesson payment not paid for within 1 week of starting a new package.**

CANCELLATION POLICY: Missed lessons are simply not acceptable. Students and Parents need to understand that scheduling matters, and that my schedule must be

respected. This is a place of business. If you do not give at least 24 hours' notice for a lesson cancellation, you are liable for the cost of that lesson. When possible, I will attempt to reschedule canceled lessons but I cannot guarantee any accommodations. **MAKE-UP LESSON POLICY:** A make-up lesson will be rescheduled for a lesson missed for the following reasons *only*: If the lesson was canceled by the riding instructor, The rider was absent from the lesson for a medical reason, and has an excuse signed by his/her doctor, There was a death in the rider's immediate family, School activities (no other school sports), and or cancellation for bad weather conditions.

AGREEMENT SCOPE AND TERRITORY - This agreement shall be legally binding upon me the registered student, and the parent or legal guardians thereof if a minor, my heirs, estate, assigns, including all minor children, and personal representatives; and it shall be interpreted according to the laws of this state and county of Alpine Ridge Farms LLC physically located.

ACTIVITY RISK CLASSIFICATION - I UNDERSTAND THAT: Horseback riding is classified as a RUGGED ADVENTURE RECREATIONAL SPORT ACTIVITY and Surveillance Systems of United States Consumer Products) horse activities rank approximately 64th in injuries that result in a stay at US hospitals. Related injuries can be severe requiring more hospital days and resulting in more lasting residual effects than injuries in other activities.

NATURE OF THIS STABLE'S SCHOOL HORSES - I UNDERSTAND THAT: Alpine Ridge Farms LLC chooses its school horses for their calm dispositions and sound basic training as is required for use for Student Riders and Alpine Ridge Farms LLC follows a rigid safety program. Yet no riding horse is a completely safe horse. Horses are 5 to 15 times larger, 20 to 40 times more powerful, and 3 to 4 times faster than a human. If a rider falls from horse to ground it will generally be a 3 ½ to 5 ½ feet, and the impact may result in injury to the rider. Horseback riding is the only sport where one much smaller, weaker predator animal, the human, tries to control and become one unit of movement with another much larger, stronger prey animal, the horse, with each having a limited understanding of the other. If a horse is frightened or provoked it may divert from its training and act according to its natural survival instincts which may include, but are not limited to: stopping short: changing direction or speed at will; shifting its weight from side to side, bucking, rearing, biting, kicking or running from danger.

RIDER'S RESPONSIBILITY - I UNDERSTAND THAT: Upon mounting a horse and taking up the reins the rider is in primary control of the horse. The rider's safety largely depends upon his/her ability to carry out simple instructions, and his/her ability to remain balanced aboard the moving animal. I agree that the rider shall be responsible of his/her safety, including that of an unborn child, if the rider is pregnant. Pregnant women should ride horses only under the advice of their physician. THIS STABLE advises pregnant women not to ride horses.

CONDITIONS OF NATURE AND INSPECTION OF PREMISES - I UNDERSTAND THAT; THIS STABLE is NOT responsible for total or partial act, occurrence, or elements of nature that can scare a horse, cause it to fall, or react in some other unsafe way. SOME EXAMPLES ARE: Thunder, lightning, rain, wind, wild and domestic animals, insects, reptiles, which may walk, run or fly near, or bite or sting a horse or person; and irregular footing in an arena, or wild land which is subject to constant change in condition according to weather, temperature, and natural and man-made changes in landscape. The rider and parent or legal guardian have inspected THIS Stable's facility and are satisfied that all premise conditions are reasonable safe for the rider's intended purpose, usage and presence upon Alpine Ridge Farms LLC.

SADDLE GIRTHS/NATURAL LOOSENING - I UNDERSTAND THAT; Saddle girths may loosen during a ride. If a rider notices this he/she must alert the riding instructor as quickly as possible so action can be taken to avoid slippage of saddle and a potential fall from the animal.

ACCIDENT/MEDICAL INSURANCE - I AGREE THAT; **should emergency medical treatment be required, I and/or my own accident/medical insurance company shall pay for all such incurred expenses.**

PROTECTIVE HEADGEAR WARNING - I AGREE THAT; I for myself and on behalf of my child and/or legal ward have been fully warned and advised by Alpine Ridge Farms LLC that protective headgear which meets or exceeds the quality standards of the SEI CERTIFIED ASTM ATANDARD F 1163 Equestrian Helmet, should be purchased and worn while riding and being near horses and I don't understand that the wearing of such headgear at these times may reduce severe head injuries and possibly prevent the wearer's death from happening as the result of a fall and other occurrences.

RELEASE, WAIVER AND INDEMNITY AGREEMENT - *In consideration of Alpine Ridge Farms LLC allowing my participation in this activity under the terms set forth herein, I, the rider, for myself and on behalf of my child and/or legal ward, heirs, administrators, personal representatives or assigns, do agree to completely hold harmless*

and release this stable, its owners, agents, employees, officers, directors, representatives, assigns, members, owner of premises, affiliated organizations, Insurers and other acting on this stable's behalf (hereinafter, collectively referred to as "Associates"), of all claims, demands, causes of action, and legal liability, whether the same be known or unknown, anticipated or unanticipated, due to this stable gross negligence and willful and wanton misconduct, I shall not bring any claims, demands, legal actions and causes of action, against this stable and its associates as stated above in this clause, for any economic and non-economic losses due to bodily injury, death, property damage, and injury to, or loss by death, sustained by me and/or my minor child and/or legal ward in relation to the premises and operation of this stable, to include being near horses owned by or in the care, custody and control by this stable, whether on or off the premises of Alpine Ridge Farms LLC.
